SIX FLAGS HURRICANE HARBOR CONCORD - PARK POLICIES

Because Six Flags Hurricane Harbor Concord is a family park, we expect guests to behave appropriately. Violating our park policies may be cause for ejection from the park without refund.

BEHAVIOR

We expect all guests to behave in a family-friendly manner. Line jumping, profanity and unruly behavior are offensive to park guests and may be cause for ejection without refund. Guests are not permitted to save places in line, bypass others in line, or exit the line and return to the same place for any reason. Guests exiting a line must go to the back of the line if they choose to return.

DRESS CODE

In keeping with our family-friendly atmosphere, and for health and safety reasons, Six Flags strictly enforces a dress code. Proper swimwear is required. Swimwear with rivets or any other metal ornamentation is not permitted on the water slides. Clothing or tattoos with offensive language or graphics are not permitted at any time.

Examples of clothing not permitted are those displaying:

- Profanity
- Pornography
- Graphic violence
- Support of drugs and drug use
- Gang symbols
- Promotion of discrimination against any group

Provocative swimwear and long pants are not permitted. All children must be in appropriate swimwear. Children wearing diapers must wear an approved WATERPROOF DIAPER available at Tradewinds.

Park admission may be denied if clothing or tattoos are deemed to be inappropriate by management and the Guest refuses all reasonable options. Shirts cannot be turned inside out as a solution.

INCLEMENT WEATHER

For your safety, certain rides may need to close during severe weather, such as electrical storms, heavy rain, or high winds. Most restaurants and shops will remain open. Rides will re-open as soon as safe operations can be assured. Unfortunately, refunds and rain checks are not offered for inclement weather.

LANGUAGE

Guests using profanity or abusive language, symbols or gestures may be ejected from the park without refund.

LINE JUMPING

Line jumping is strictly prohibited. Guests are not permitted to save places in line or exit the line and return for any reason. Violators will be ejected without a refund.

LOOSE ARTICLES

Loose articles are not permitted on most rides and should be left with non-riders or secured in lockers. Six Flags and its employees are not responsible for lost or stolen items.

PETS

Pets are not allowed, with the exception of working service animals.

PHOTOGRAPHY

By entering the park, guests grant Six Flags the right to film, video, record or photograph them on park property for any reason without payment or consideration. Six Flags requests that all photographs or video taken by our guests be used for their personal use and enjoyment only. Any use, reuse or reproduction for commercial purposes without the express written consent of Six Flags is strictly prohibited. Six Flags reserves the right to refuse to allow photography of any kind as necessary at individual locations. No commercial photography of any kind is permitted. Specifically, the use of the following equipment is not permitted:

Go Pro cameras
Lenses greater than three-and-one-half inches in length
Interchangeable lenses of any kind
Any camera mounted to a vehicle, drone, cart, scooter or other moving object

No cameras (video, still, cell-phone, smart phones, etc.) are allowed on any rides at any time. No exceptions.

All Six Flags rides, shows and attractions are protected by copyright. Guests must have written permission to use photographs and/or videotape of Six Flags images for commercial broadcasting, advertising, marketing or publishing in any medium.

PROHIBITED ITEMS

The following items are not permitted at any time:

- Food/coolers*
- inner tubes (available to rent at park only)
- Lawn/folding chairs
- Magic markers, spray paint
- Aerosol cans
- Glass bottles
- Knives, Multi-tools or other similar items regardless of size
- Spiked clothing/jewelry
- Fireworks/explosives
- Firearms/ammunition
- Chemical weapons, mace/pepper spray
- Skate shoes or any footwear with wheels
- Selfie sticks, monopods, and similar items
- Unmanned ariel vehicles (drones)
- Bluetooth speakers
- Pop-up tent/shade structure
- Segway
- Spiked beach umbrella

*Food exceptions are made for Guests with special dietary needs to include food allergies and baby food/formula, but coolers are not allowed.

RAIN POLICY

Some rides will close temporarily during electrical storms, heavy rains, high winds and other severe weather conditions. As soon as conditions permit safe operation, these attractions will re-open. Six Flags Hurricane Harbor does not issue rain checks or refunds.

RE-ENTRY

To leave the park and re-enter on the same day, please get your hand stamped and re-enter at the re-entry gate. This includes Season Pass holders. Season Passes may only be scanned once per day.

RIDE RESTRICTIONS

Safety is our number-one priority. Guests with certain body proportions or of certain heights and/or weights may not be able to enjoy certain rides if the safety restraints will not operate as designed.

RIDER RESPONSIBILITY

There is an inherent risk in participating in any amusement ride. We expect riders to exercise good judgment and act in a responsible manner. Guests must also obey all oral and written warnings and properly use all ride safety equipment provided. Guests who do not comply with ride rules may be ejected from the park without refund. Please refer to specific guidelines posted at the entrance of every ride.

SELFIE STICKS, MONOPODS, & SIMILAR DEVICES

Selfie sticks, monopods, and similar devices are not allowed inside Six Flags parks.

SMOKING POLICY

Six Flags Hurricane Harbor is a smoke-free environment. Smoking (including E-cigarettes) is prohibited everywhere within the Park. Guests must exit the front gate and be at least 25 feet away from the main gate to smoke.

UNMANNED AERIAL VEHICLES (UAVs)

To ensure the safety and enjoyment of all guests, Six Flags prohibits the operation or use of any unmanned aerial vehicle on, from, or above Six Flags' premises absent specific written consent. This includes all UAVs, also commonly known as "drones," regardless of their size, weight or purpose.

LIFE VESTS

Lifejackets must be Coast Guard approved and are available free of charge in various locations throughout Hurricane Harbor. Lifejackets are required for weak swimmers and guests under 48". Six Flags recommends that parents supervise children and others with disabilities at all times while in Hurricane Harbor. Children under 48" or others that cannot swim must be within arm's reach of parent/guardian when in the water.
