

#MoveWithNorthShore Sweepstakes

Official Rules

NO PURCHASE, PAYMENT OR DONATION IS NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT OR DONATION WILL NOT INCREASE OR IMPROVE YOUR CHANCES OF WINNING. VOID IN ALASKA AND WHEREVER PROHIBITED BY LAW.

EACH ENTRANT MUST BE AT LEAST FOURTEEN (14) YEARS OF AGE AS OF THE ENTRY DATE OF THE SWEEPSTAKES. IF YOU ARE A MINOR, ASK YOUR PARENT OR LEGAL GUARDIAN FOR PERMISSION AND TO HELP YOU ENTER.

1. **ELIGIBILITY.** The #MoveWithNorthShore Sweepstakes (the "Sweepstakes") is open only to individuals who, as of the entry date, are (a) legal residents of Illinois, Wisconsin and Indiana (the "Sweepstakes Territory") and (b) at least fourteen (14) years old. Eligible minors must obtain their parents or legal guardian's permission prior to participating. The Sweepstakes is void outside of the Sweepstakes Territory and where prohibited or restricted by law. Employees, officers, directors and managers of Six Flags Theme Parks Inc. 2. **ENTRY PERIOD.** The Sweepstakes entry period begins at 12:00 a.m. Eastern Time ("ET") on July 1, 2021 and ends at 12:59 p.m. ET on August 31, 2021 ("Entry Period"). Sponsor's computer shall be the official timekeeper for purposes of the Sweepstakes.
3. **HOW TO ENTER.** To enter the Sweepstakes, an entrant must have either a Facebook, Twitter, or Instagram account. If you do not have a Facebook, Twitter, or Instagram account, you may create one for free by visiting www.Facebook.com, www.Twitter.com, or www.Instagram.com. By submitting your information and creating an account, you agree to the terms of use and privacy policy of Facebook, Twitter, or Instagram, as applicable. If you do not agree to such terms of use and privacy policy, you cannot create a Facebook, Twitter, or Instagram account or participate in this Sweepstakes. If entrant is using his or her mobile device to enter, charges, including message and data rates, may apply. Entrants should consult their wireless service provider regarding its pricing plans.
 - a. To enter the Sweepstakes, entrants must post at least one (1) photo post on Facebook, Twitter or Instagram during the Entry Period with original photo(s) with at least one (1) of the two (2) specially marked NorthShore branded Movement Mile displays at Six Flags Great America, located in Gurnee, Illinois, using the hashtag #MoveWithNorthShore ("Photo"). Each Photo shall comply with the following instructions and meet the requirements set out below ("Submission Requirements"). The two (2) specially marked NorthShore Movement Mile

photo displays can be identified by a 3' x 5' 'Sweepstakes Informational Billboard' adjacent the display. Both display photo opportunities are situated safely on the park midway in their respective area of the park. A minimum of one (1) photo is required prior to the first drawing on the last day of July, to qualify for both drawings. There is no maximum to the number of photos you may upload during the Entry Period, however posting multiple photos will not increase your chances at winning. You will qualify for the corresponding drawing as described below, depending on the post date of the first image with hashtag. Hashtag #MoveWithNorthShore must be included in at least one uploaded picture to qualify. A qualifying photo post must clearly include entrant's face/partial face along with qualifying display in background.

- b. Photos may be taken on separate visits and uploaded throughout Entry Period with either of the NorthShore Movement Mile photo displays. How many of the two (2) drawings Entrants qualify for depends on when first photo is uploaded to any of the qualifying social media platforms:

If entrant's first photo(s) post is uploaded July 1, 2021 through July 30, 2021, the post will qualify as an entry for both drawings in the Sweepstakes taking place on July 31, 2021 and September 1, 2021.

If entrant's first photo(s) post is uploaded August 1, 2021 through August 31, 2021, the post will qualify as an entrant for the remaining final drawing on September 1, 2021.

- c. One may also enter the sweepstakes by emailing socialmedia@northshore.org. How many of the two (2) drawings Entrants qualify for depends on when Entrant sends in his/her email to aforementioned email address:

If entrant's first email is sent July 1, 2021 through July 30, 2021, the post will qualify as an entry for both drawings in the Sweepstakes taking place on July 31, 2021 and September 1, 2021.

If entrant's first email is sent August 1, 2021 through August 31, 2021, the post will qualify as an entrant for the remaining final drawing on September 1, 2020.

- d. Each entrant may only use one (1) account to enter the Sweepstakes. Entries made from the same person on multiple accounts will not count as extra entries. All online entries must be received by Sponsor during the Entry Period. In the event of a dispute as to the identity of an online entrant, the authorized account holder of the account used to enter will be deemed to be the entrant. Potential winners may be required to show proof of being the authorized account holder. The "authorized account holder" is the natural person assigned to an account by an Internet service provider, online service provider, or other organization responsible for assigning accounts for the domain associated with the submitted account. All entries will be deemed to have been made by the authorized account holder of the submitted social media account. Submitting mass entries or entries generated by a script, macro or use of automated

devices is prohibited and will result in disqualification. There is no maximum to the number of photos from any person or account, however, uploading multiple photos will not increase your chances at winning. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.

- e. By entering the Sweepstakes, each entrant grants Sponsor and NorthShore University HealthSystem a non-exclusive, royalty-free, irrevocable right to reproduce, copy, publish, display, distribute, perform, translate, adapt, modify, feature and otherwise use the entrant's Photo and any accompanying caption posted by entrant (together, the "Materials"), without restriction and without compensation, notification, or additional consent from entrant or any third party. Entrant warrants that he/she has the sole and exclusive right to grant such rights to Sponsor, and that the Sponsor's reproduction, publishing, displaying, and/or other use of the Materials (in whole or in part) will not infringe on any rights of third parties, including, but not limited to, copyright, trademark, privacy, or publicity rights, or create claims for breach of contract, anywhere in the world. Entrant agrees that Sponsor shall have no obligation to copy, publish, display, or otherwise exploit the Materials.

4. **PHOTO SUBMISSION REQUIREMENTS.** Each entry (including all Materials) must comply with the following:

- a. Must clearly include entrant's face/partial face with facemask on covering both mouth and nose, along with qualifying display in background.
- b. Must be the entrant's original photo/idea (modification of an original work is not an original idea).
- c. Must comply with the applicable community guidelines, terms of use, and any other binding terms on Facebook, Twitter, or Instagram.
- d. Must not include materials, language, phrases, quotations, artwork, objects etc. belonging to or copyrighted by third parties other than Sponsor or NorthShore University HealthSystem.
- e. Must have approval from any persons appearing in the Photo and entrant must be able to provide express written consent of every such person appearing in the Photo (or if such person is under 13 years old, then express written consent of the minor's parent/guardian) to Sponsor if requested.
- f. Must not have been previously published or otherwise exhibited. (Do NOT copy/re-post other persons' photos or comments).
- g. Must not include reference to, or images, names or likenesses of, third parties (whether they are public or private figures), including but not limited to minors, celebrities, athletes, musicians and friends, who have not expressly authorized entrant to display their image or likeness in any submitted application or otherwise use such references, names, images or likenesses in accordance with these Official Rules.
- h. Must not contain any obscene or otherwise objectionable material (as determined by Sponsor in its sole discretion).
- i. Must not contain, facilitate, reference, or use material that is dangerous, fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous.
- j. Must not disparage or adversely affect the goodwill and business reputation of Sponsor.
- k. Must not contain any unsolicited or unauthorized advertising, promotional materials, or any other form of solicitation.

- l. Must not contain any material that: (a) would give or threaten to give rise to criminal or civil liability; (b) encourages conduct that constitutes a criminal offense; (c) encourages or provides instructional information about illegal activities or (d) references any brand name products or services, or any third party logo or other intellectual property, with the exception of products and services offered by, and/or logos of, Sponsor.
- m. Sponsor reserves the right in its sole and unfettered discretion to disqualify any entry that it believes is inappropriate or not suitable for publication, that does not comply with these Official Rules, or that is not consistent with the spirit or theme of this Sweepstakes. Entrant acknowledges that entrant will not receive any compensation of any kind for his/her entry. Materials generated by script, macro or other automated means are void, as are entries that are illegible, garbled, incomplete, or that contain errors. 5. **PHOTO AGREEMENT TO OFFICIAL RULES AND DECISIONS.** By entering the Sweepstakes, each entrant (and each minor entrant's parent or legal guardian on behalf of himself/herself and on the minor's behalf) irrevocably, fully and unconditionally agrees to be bound by and accepts these Official Rules and the decisions of Sponsor (including, without limitation, decisions regarding eligibility of entries and entrants, the selection of winners, and the awarding of prizes), which are final and binding in all respects.
