## INTRODUCTION:

We are thrilled you have chosen to spend your day at Six Flags! Our goal is to make your visit fun and memorable. This Six Flags Guest Safety and Accessibility Guide includes important information to assist Guests with planning their visit to the park and enjoying its various attractions, rides, services and amenities. In this Guide, Guests will find specific information for individuals with disabilities along with general policies and guidelines.

We work closely with the manufacturer of each of our rides and our policies incorporate the manufacturers' guidelines as well as the requirements of the Americans with Disabilities Act. We hope that this Guide will help Guests make the best choices to ensure a safe, comfortable and convenient experience at the park. If, at any time, Guests need additional assistance or a further explanation of our policies and guidelines, they should feel free to ask any Six Flags Team Member.

Our goal is to safely and efficiently accommodate the needs of all Guests, including individuals with disabilities. This Guide, along with the availability of our Team Members to answer any questions and offer assistance, will allow Guests to have a thrilling and safe day at the park.

### **GENERAL WARNING:**

We are committed to providing you a safe environment during your visit to Six Flags. While there are inherent risks to participating in any amusement park ride or attraction, our goal is to ensure your safety with the incorporation of some restrictions. For your safety, you should be in good health to ride. Only you know your physical conditions or limitations.

Many amusement park rides incorporate safety systems designed by the manufacturer to accommodate people of average physical stature and body proportion. These safety systems may place restrictions on the ability of a Guest to safely be contained within the ride restraint. Extremely large or small individuals, Guests who have heart, back or neck trouble or conditions, pregnant women, people who have had recent surgery or an illness, people with casts, braces, restrictive devices or certain disabilities may not be safely accommodated by certain ride systems. For example, height requirements are based on the size needed for safety restraints to function properly and the level of maturity usually associated with a certain height.

If you suspect your health could be at risk for any reason, or you could aggravate a pre-existing condition of any kind, **DO NOT RIDE**. The specific features, rider requirements and health restrictions of each ride are described later in this Guide.

In order to ride, all Guests must be able to maintain the proper riding position, meet the ride requirements and appropriately utilize the restraint systems, including lap bars, shoulder harnesses and seatbelts as indicated. All Guests must also be able to demonstrate a willingness and ability to comply with verbal and written rider requirements.

Six Flags reserves the right to make the final determination regarding the eligibility of a Guest to ride a particular ride based on the Guest's size, weight, height or other limitations. Information in this Guide is subject to change.

#### RIDER RESPONSIBILITY:

All Guests have a duty to exercise good judgment and act in a responsible manner while participating on a ride or attraction and to obey all verbal and written warnings and instructions. Guests also have a duty to properly use all ride and attraction safety equipment provided.

### **PARKING:**

Accessible parking is available on a first-come, first-serve basis within the main parking lots of the park. When you arrive at the parking toll booths, ask a Team Member for instructions regarding the accessible parking lot. Both auto and van accessible spaces are provided. A valid disabled persons parking placard or license plate must be displayed at all times while parked in the designated accessible parking area. If the designated accessible parking area is full at the time of your arrival, members of your party may be dropped off at the main pick-up/drop-off area, near the main entrance to the park. Please ask a Team Member for directions to additional parking areas.

## WHEELCHAIRS AND ELECTRIC CONVENIENCE VEHICLES (ECV'S):

Wheelchairs and electric convenience vehicles (ECVs) are available for rent at the Rental Center, located next to the lockers. You must be at least 18 years of age to rent or utilize an ECV. A deposit is also required. Guests may also use their own wheelchairs or ECVs. If you need to take the rented wheelchair or ECV outside of the park, a Team Member escort is necessary to do so. Please ask for assistance at the park exit. Battery recharging is also available at the Rental Center. ECV's must be operated in a safe manner, only one person may be on the ECV while moving, must have 3 wheels and cannot exceed 5 miles per hour while moving in the park or on Six Flags property.

Guests using wheelchairs or ECVs may utilize any ticket window and turnstile to enter the park. Many of the park's shopping and dining facilities are also wheelchair accessible. Many of the rides and attractions have queues that are accessible to Guests using manual wheelchairs. If an alternate entrance is required, these entrances are generally at the ride exit and are identified by a sign with the universal wheelchair symbol. Please keep in mind that there are specific boarding requirements and accommodations for those using wheelchairs at each ride or attraction.

#### **SEGWAY:**

Due to varying walkways, terrains and large crowds, we cannot permit the use of two-wheeled, self-balancing electric vehicles such as Segways. We are pleased to offer other forms of transportation, including ECVs and standard wheelchairs. Please contact Guest Relations for more information.

#### SERVICE ANIMALS:

Trained service animals are welcome at our Six Flags Theme Parks. Service animals are defined as dogs that are individually trained to do work or perform tasks for people with disabilities. Examples of such work or tasks include guiding people who are blind, alerting people who are deaf, pulling a wheelchair, alerting and protecting a person who is having a seizure, reminding a person with mental illness to take prescribed medications, calming a person with Post Traumatic Stress Disorder (PTSD) during an anxiety attack, or performing other duties. Service animals are working animals, not pets. The work or task a dog has been trained to provide must be directly related to the person's disability. Dogs whose sole function is to provide comfort or emotional support do not qualify as service animals. Miniature horses that have been individually trained to do or perform tasks for people with disabilities will qualify as service animals.

Service animals must be house broken and remain on a leash or harness and under the control of their handler at all times. Guests whose service animal demonstrates aggressive and/or annoying actions toward a Guest or Team Member will be directed to remove the animal from the park. Service animals are welcome in most locations of the park. Most of our rides are not equipped or designed for accessibility to service animals. Therefore, a member of your party must be available to stay with the animal while you ride.

**Rides:** Service animals, excluding miniature horses, are permitted on the Silver Star Carousel (in the non-motion chariot), **Sylvester & Tweety's** State Fair-is Wheel, the Oil Derrick, and the Six Flags Railroad.

**Haunted Mazes:** Guests with service animals, please note that these attraction uses loud noises, theatrical lighting, special effects, and sudden moments intended to provide our guests with a thrilling experience. We rely on you to determine whether this attraction is appropriate for your service animal to experience. We remind guests with service animals that they must maintain full control of their service animal at all times while in the Park.

Guests may take advantage of our Kid Swap policy for staying with their service animal. However, Team Members will not take responsibility for, or provide care to any service animal. Refer to the section on Kid Swap for more information.



Service Animal Relief Areas are located in the grass areas next to Cloud Bouncer, between **Yosemite Sam** and the Gold River Adventure and the Oil Derrick, and across from the entrance to Gold River.

#### **RESTROOMS:**

Most restrooms within the park are accessible for Guests using wheelchairs. Please check the park map for locations.

#### **ALTERNATE ACCESS:**

Most of the park's theaters, attractions, restaurants and shops are accessible to wheelchairs. Most, if not all rides require transfer from the wheelchair to the ride seat. Special access entrances are available to accommodate Guests with mobility aides and service animals. These special entrances are generally at the ride exit and identified by a sign with the universal wheelchair symbol. Entry, exit and transfer must be accomplished independently by the Guest or the assistance of a member from his/her party. Six Flags Team Members are not trained in lifting or carrying persons with disabilities and are therefore not permitted to assist Guests on or off the rides. Not all rides have alternate access. If in doubt, please contact the Ride Attendant or Guest Relations for more information.

#### ATTRACTION ACCESSIBILITY PROGRAM:

Our goal is to safely accommodate the needs of all Guests. Our policies comply with the Americans with Disabilities Act (ADA) and applicable state laws.

Six Flags' Attraction Accessibility Program is designed to accommodate guests with disabilities or certain other qualifying impairments so they may participate in the enjoyment of our Parks. Each attraction at Six Flags has been evaluated for the criteria necessary for an individual to ride safety. Our ridership criteria (set forth on page 12 of this Guide) is based on the requirements of the attraction manufacturer and the ability of guests to utilize all safety restraints and devices as designed, while maintaining the proper riding position throughout the duration of the ride. It is our policy to allow anyone to ride who meets all of these requirements and does not cause or create a legitimate safety concern to herself/himself or others. Our Attraction Accessibility Program matches the individual abilities of our guests to the ridership criteria for each attraction.

The Attraction Accessibility Program is an accommodation designed to provide equal access to Park attractions and not to bypass other guests waiting in the standard queue.

The following procedures apply to guests who wish to participate in our Attraction Accessibility Program:

- 1. Guests can visit Guest Relations to obtain Six Flags' Safety & Accessibility Guide to review the rider requirements of each ride or attraction. This Guide is also available on our website at www.sixflags.com.
- 2. Guests with cognitive disorders, disabilities or mobility impairments who request helpful accommodations must obtain the IBCCES Individual Accessibility Card (IAC) by registering at www.accessibilitycard.org. The registration process requires the information listed below be uploaded into a secure online portal. Once a Guest has filled out the online application and uploaded necessary documentation, they will be able to access their digital Accessibility Card. Guests will present the IBCCES Accessibility Card and Information Sheet to the Ride Information Center (Guest Services) inside each park to receive any necessary accommodations.



### PROCEDURES to Obtain the IBCCES INDIVIDUAL ACCESSIBILTY CARD (IAC)

### **Documentation/Information for registration includes:**

- Contact Information: Name, email, address and phone/cell number
- Cardholder Information:
  - Recent photo of the cardholder for identification purposes
  - Birth date
  - Name of the disability/disorder (optional)
  - o Helpful accommodations needed
  - Name of the attraction you are visiting

#### Healthcare Information

- Statement from a healthcare provider or Individualized Education Plan (IEP or equivalent) including the following:
  - Full name of the healthcare professional or education professional
  - NPI number (Provider ID) \*
  - Their title
  - Their phone number
  - Their email address
  - Statement indicating the guest has a disability or other qualifying impairment under the Americans with Disabilities Act (ADA) and/or applicable state law that prevents the guest from waiting in a standard queue. Please note that the nature of the disability does not have to be provided in the statement. If the disability is of a temporary nature, the doctor's note should state the time period of the temporary disability
- \* Not required if uploading an Individualized Education Plan
- \* Individuals requesting the IAC must be 18 years or older
- \* The IAC does NOT guarantee entry to the attraction and any special accommodations
  - 3. In an effort to provide equal treatment to all of our Guests, only those Guests with a disability or other qualifying impairment and up to three (3) riding companions will be allowed to access attractions through the alternate entrance. If the guest's party is larger than four (4) Guests, the other members of the party will be required to enter the ride or attraction through the standard queue.

- 4. To obtain an Attraction Access Pass guests with disabilities, mobility impairments or certain other qualifying impairments should visit Guest Relations, inside the Park. Such guest will be required to present a valid doctor's note in order to receive an Attraction Access Pass. The doctor's note must include the name of the individual requesting the AAP, doctor's name, address, phone number and their signature on their letter head that includes their medical ID number, along with a statement indicating the guest has a disability or other qualifying impairment under the Americans with Disabilities Act (ADA) and/or applicable state law that prevents the guest from waiting in a standard queue. Please note that the nature of the disability should not be provided in the doctor's note. If the disability is of a temporary nature, the doctor's note should state the time period of the temporary disability. A photo identification must be presented at the time of issuances, (for children 12 and under, photo ID of the parent or guardian would be accepted).
- 5. In an effort to provide equal treatment to all of our guests, only those guests with a disability or other qualifying impairment and up to three (3) riding companions will be allowed to access attractions through the alternate entrance. If the guest's party is larger than four (4) guests, the other members of the party will be required to enter the ride or attraction through the standard queue.
- 6. To use the Attraction Access Pass, the guest should proceed to the attraction's alternate entrance and show the attraction attendant the Attraction Access Pass. The attraction attendant will document a reservation time that is comparable to the current wait time for the same ride/attraction. The guest, and up to three (3) riding companions, can then return to the attraction, using the alternate entrance, at the time of the reservation in order to ride.

A guest using an Attraction Access Pass may rest in a comfortable location or enjoy other attractions in the area until the assigned reservation time has come or when the others from the guest's party waiting in the standard queue reach the boarding platform. There is a 15 minute grace period for late arrivals.

A guest with an Attraction Access Pass must ride in order for the guest's companions to utilize the Attraction Access Pass to enter the attraction through the alternate entrance. If the guest with an Attraction Access Pass chooses not to ride, the guest's companions must wait in the standard queue.

Attraction Access Passes are not designed to bypass or "skip" the standard queue and the wait will be equal to the posted wait times. Individuals found to be fraudulently using the Attraction Access Pass will be in violation of our Guest Code of Conduct and may be subject to civil penalties. Violators may also be asked to leave the Park without any refund.

### PERSONAL CARE ATTENDANT:

The Personal Care Attendant (PCA) program is designed to accommodate guests with disabilities who are in need of support services such as personal hygiene, eating, toileting, transferring, safe movement, maintaining continence and/or medication management, in order to participate in the Park's goods, services and attractions. The PCA's attendance is required to enable the guest to participate in the Park's goods, services and attractions. The PCA is not a guest and shall not participate in any of the Park's good, services or attractions separate and apart from their client. The PCA receives compensation for the PCA's services, and the PCA is professionally licensed as a home health aide. If the Park discovers that the guest or the PCA has misrepresented the purpose of the PCA or that the PCA has acted as a patron of the Park as opposed to a PCA, the PCA and the guest will be expelled from the Park and may be barred from future entry.

#### **MEDICAL DEVICES AND MOBILITY AIDES:**

For your safety and the safety of others, riders may be required to remove medical devices, half or full length orthotics, braces, crutches, canes, prosthetics and any other type of medical assistance device that is not permanently affixed to the rider's body to prevent hazards or loss due to ride forces. These devices prevent safety restraints from working as designed, keep the rider from maintaining the proper riding posture, and present a hazard to the rider or others. If in doubt about your ability to safely experience a ride or attraction, please refer to the Rider Requirement Sign at the ride entrance. You may also consult with a Ride Attendant or Guest Relations for more information.

Please also refer to the "Ride Information" section of this Guide for specific information regarding removal of medical devices and mobility aides on a ride by ride basis. If you have any questions, please ask a Ride Attendant or visit Guest Relations.

#### LARGER FRAMED GUESTS:

Many rides incorporate safety systems designed by the manufacturer to accommodate people of average physical stature and body proportion. These systems may place restrictions on the ability of an individual to safely experience the ride

In order to ride, all seatbelts, lap bars, and shoulder harnesses must be positioned and fastened properly. Due to rider restraint system requirements, Guests of a larger size may not be accommodated on some rides.

### **KID SWAP:**

The Kid Swap program is designed to accommodate groups with younger children who may not be tall enough to ride some attractions. To participate: 1) The entire party should enter the ride queue; 2) When preparing to board, tell the Ride Attendant you are using the Kid Swap program; 3) Children who are not tall enough to ride may wait at the exit with an adult from your party; 4) After the first ride is completed, the adult who waited with the child will be allowed to ride.

#### **RIDE RATINGS AND WARNINGS:**

Ride warning signs can be found at the entrance of each ride to help determine the attractions that are best for Guests based upon their experience level, physical condition and abilities. Information on each ride can also be found on the Park Map and Guide.

# GENERAL INFORMATION

#### **FRIGHT FEST:**

Theatrical fog effects, areas of low lighting, loud music, sound effects, and theatrical and strobe lighting are used throughout the park during Fright Fest. This includes streets, midways, outdoor scare zones, mazes and haunted houses both indoor and outdoor, live entertainment venues and children's attractions.

Guests with respiratory sensitivities, history of seizures or epilepsy, or sensitivities to latex, loud music and sound effects are advised not to participate in these attractions. Please adhere to all posted and verbal warnings and directions.

#### FAMILY SERVICES/NURSING MOTHERS:

A private area for nursing mothers is available upon request at Lost Parents in **Bugs Bunny** Boomtown. Baby changing areas can be found in most restrooms. Please feel free to ask a Team Member for directions to these locations or review a park map.

#### **HEARING DISABILITIES:**

Assisted listening devices are available upon request. Please see Guest Relations for additional information. American Sign Language Interpreting will be available if requested at least 7 days in advance of your visit. To arrange for sign language interpreting services, please call the Operations Office at (817) 640-8900 x4500.

#### **VISUAL IMPAIRMENTS:**

Guest with Visual Impairments -Guests with Visual Impairments that require assistance from a Personal Care Attendant (PCA) will be provided a complimentary ticket for their PCA, provided the PCA meet the Personal Care Attendant guidelines. (See guidelines for Personal Care Attendant.)

#### PREGNANCY:

Guests who know or believe they may be pregnant should follow all rules, guidelines and restrictions listed for each ride. Those who are pregnant should not ride a ride that specifically lists pregnancy as a rider restriction. Please closely review all rules and guidelines at the entrance of each ride.

## FOOD, DRINKS AND COOLERS:

Food, beverages, coolers and grills may not be brought into the park. The only food exceptions are for food allergies as described below and infant food, in non-glass jars. Six Flags Over Texas prohibits the use of grills and open flames in and around the property, including parking lots.

#### **FOOD ALLERGIES:**

Guests who suffer from sensitivities or life-threatening allergies may bring food into the park if they do not feel comfortable with the menu options available. In this case, the food must be limited to the individual with the allergy and may contain: two sealable sandwich bags (7x8 inches) and one snack to accommodate their visit (such as a piece of fruit, or a fruit bar, or a snack that fits in a sandwich bag). One small soft-sided cooler may be brought into the park to carry these items. No outside beverages are permitted. Please see Security at Six Flags metal detectors to receive a medical sticker.

#### **FIRST AID:**

Emergency Medical Technicians or Paramedics are on duty during all park operating hours. If you require medical assistance, ask any Team Member and they will summon medical personnel to your location. Please refer to your Park Map and Guide for the location of First Aid.

### **OXYGEN TANKS/AIR CONCENTRATORS:**

Due to the dynamics and certain characteristics of the rides, oxygen tanks or portable systems are not permitted on most of our rides and attractions. Oxygen tanks are permitted in enclosed facilities. For your convenience, the park's First Aid station(s) will be able to appropriately store your additional oxygen tanks during your visit.

### SPECIAL EFFECTS AT THEATERS, RIDES AND ATTRACTIONS:

Theatrical fog and other effects, including but not limited to: haze and other atmospheric effects, scents, areas of low lighting, loud music, sound effects, theatrical lighting and strobe lighting may be used at various locations in the park such as theaters and during Fright Fest. Guests with respiratory sensitivities, history of seizure or epilepsy, or sensitivities to latex, loud music and sound effects are advised not to participate in these attractions. Please adhere to all posted and verbal warnings and directions.

## RIDE INFORMATION

#### **CAMERAS:**

Picture taking and the use of cameras and video recording devices is not permitted on any ride, while it is in motion. It is encouraged that Guests leave their equipment with a non-rider or secure it in a locker or their vehicle. Lockers are available to store items for a nominal fee. Guests must have written permission to use photographs and/or recordings of any aspect of the park for commercial broadcasting, advertising, marketing, or publishing in any medium.

### **FULL BODY HARNESS:**

The safety of our quests and employees is always our highest priority and we strive to provide a fun, safe experience for all guests. In an effort to better accommodate the needs of guests with certain disabilities, we have worked with ride manufacturers to develop safety harnesses for select rides in our park. Riders who do not meet certain extremity requirements may be able to ride **BATMAN** – The Ride utilizing the full body harness [if all requirements are met]. Our ride operators have been trained to assist quests with the harnesses to ensure their safety and enjoyment.

#### **RIDE EVACUATIONS:**

If a ride evacuation is necessary, Guests may need to negotiate stairs from the highest points of the ride down steeply inclined stairs or walking surfaces. Guests requiring assistance during the ride evacuation may be escorted last in order to expedite the ride evacuation process. Please ask a Ride Attendant about the specific procedures prior to boarding a particular ride.

#### **DEFINITIONS:**

Every ride entrance lists height requirements and special instructions regarding the ride. Six Flags uses the following terms:

- **Responsible Person:** A responsible person is someone who meets all the requirements to ride the ride themselves and is at least 54" tall or taller.
- Accompanied By: Whenever a Guest needs accompaniment, the accompanying person must
  meet all the ride requirements and be able to assist the Guest including helping the Guest to
  board and exit the ride and assisting the Guest down stairs, catwalks, or ladders in case of an
  evacuation.
- Lap Child: A lap child is a child who is unable to walk to the ride independently or maintain independent seated postural control.
- **Functioning Extremity:** A functioning extremity is a limb over which a person has control. A prosthetic device is not considered a functioning extremity. Six Flags has additional requirements regarding prosthetic devices. Please see the information for each specific ride in the Ride Information section of this Guide.
- **Ability to hold on or brace:** Ability to use one's arms to maintain a grasp on an assist bar and support one's body during normal and emergency procedures on a ride and to use one's legs to brace to maintain a seated position during the ride.
- **Functioning Arm:** is a full arm with the ability to be flexed at the elbow and a minimum of three full fingers with the ability to hold on with a firm grip.
- Functioning Leg: is a fully formed natural leg with a foot.

## **LOOSE ARTICLE POLICY:**

- Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on the following rides: BATMAN The Ride, CATWOMAN Whip, Diver Bomber Alley, HARLEY QUINN Spinsanity, THE JOKER, MR. FREEZE: Reverse Blast, New Texas Giant, THE RIDDLER Revenge, Shock Wave, SUPERMAN: Tower of Power, Texas SkyScreamer, Titan. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets available on Texas Giant and Titan, or left in article bins available on select ride docks.
- For the balance of rides, loose articles including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (New Texas Giant, Runaway Mountain, and Titan only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a nonrider.

## **BATMAN – The Ride** (Inverted Looping Coaster)

An exciting roller coaster with high speeds, drops, fast turns, and loops.

Height Restriction: Riders must be at least 54 inches tall to ride.

Physical Requirements: Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including shoulder harnesses and seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Stay seated, face forward, keep head arms, and legs inside ride at all times. Riders with arm or leg cast shall not ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride. Riders who do not fit the restraint system are not allowed to ride. A rider fits the restraint if the third "click" of the restraint mechanism and the safety belt can be engaged.

**Extremity Requirement:** No arm or leg casts. No prosthetic devices. Riders must have two (2) natural functioning arms with two (2) natural functioning hands capable of grasping, and at least two (2) natural legs to the knee on both legs. A rider with one (1) missing arm or hand may ride, provided such rider has the ability to hold on with one (1) natural functioning hand capable of grasping and bracing himself/herself with two (2) natural functioning legs. Riders who do not meet the extremity requirements, maybe able to ride utilizing a full body harness, if the requirements set forth by the manufacturer of the full body harness are met.

**Ride Access:** Riders utilizing the AAP will enter through **THE FLASH** Pass entrance to the left of the main queue and behind the ride. Riders using a wheelchair or ECV, should enter through the ride exit.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

# **BATWING** (Family Circular Ride)

A gentle ride with a circulating, up and down motion.

Height Restriction: Riders under 48 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## **Boot Scootin'** (Family Circular Ride)

A gentle ride with a circulating, up and down motion.

Height Restriction: Riders under 36 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## **Bugs Bunny Cloud Bouncer** (Bouncing Ride)

A child's ride with elevation and short drops.

**Height Restriction:** Riders under 42 inches must be accompanied by an adult. Adults over 54 inches may only ride when accompanying a rider under 54 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. No leg casts. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

# Caddo Lake Barge (Family Spinning Ride)

A mild family ride with circulating and spinning motions.

Height Restriction: Riders under 42 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## **Chaparral Antique Cars** (Family Car Ride)

Low speed, forward motion, antique car simulation. Minor bumping may occur.

**Height Restriction:** Riders under 42 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Drivers must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to drive.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

# **CATWOMAN Whip** (Circular Ride with Tilting Motion)

An exciting circular ride that has elevation and a tilt.

Height Restriction: All guests must be 48 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including shoulder harnesses and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast positioned on the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least two (2) natural functioning arms that extend at the minimum to the elbow and one (1) natural functioning hand capable of grasping on one of the two arms, and at least two (2) natural legs with lower extremities to the knee on both legs in order to ride. No prosthetic devices.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

# **Cloud Bouncer** (Family Spinning Ride)

A gentle ride with a circulating, up and down motion.

**Height Restriction:** Riders under 42 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

Ride Access: All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the

# **Conquistador** (Swinging Ship)

A family ride with an oscillating back and forth motion.

**Height Restriction:** All riders under 42 inches must be accompanied by an adult and sit towards the center of the boat, with the adult sitting towards the outside of the boat.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

# **Daffy Duck Bucket Blasters** (Water Blast Ride)

A gentle circular ride with blasts of water from other riders.

**Height Restriction:** Riders must be at least 36 inches tall to ride. Riders between 36 and 48 inches tall must be accompanied by an adult. Adults over 54 inches may only ride when accompanying a rider under 54 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints must be fastened properly to allow Guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

Closed during Holiday in the Park.

## **Dive Bomber Alley** (Sky Coaster)

A thrilling free fall attraction with exciting swinging action.

This attraction requires an additional charge.

**Height Restriction:** Riders must be at least 42 inches tall. Guests between 42 and 48 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Do not ride if you are not willing or do not have the ability to grasp and hold onto the landing loop with both hands during the landing process. Maximum combined weight of flyers is 850 pounds. Riders with arm casts must ride with the cast toward the outside of the ride. Boarding requires going up stairs into the loading platform.

**Extremity Requirements:** By reason of the restraint system inherent in flight suits, it is necessary that flyers must have two (2) arms and at least one (1) leg to be restrained by flight suit.

**Ride Access:** Ride Access: All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

## El Asseradero (Log Flume Ride)

Float through water at mild speeds and medium hills.

Height Restriction: Riders under 42 inches tall must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. No lap children. Leg casts must be able to bend at the knee. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride. You will get wet.

**Extremity Requirement**: Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV should enter through **THE FLASH** Pass entrance, located in the Mexico area of the park behind Totally Kickin' Chicken.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

Closed during Holiday in the Park.

# El Sombrero (Spinning Hat Ride)

A family ride with spinning and up and down motions.

Height Restriction: All riders under 42 inches must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Rider positions may be adjusted to ensure proper weight distribution. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

#### El Diablo

High thrill, an exciting roller coaster that loops upside down in an elevated circular motion.

**Height Restriction:** Riders must be at least 48 inches tall to ride this ride.

**Physical Requirements:** Each rider must maintain in an upright seated position with their back against the seatback during the duration of the ride and their arms, hands, legs, and feet inside the ride vehicle at all times. In addition, riders must possess two (2) naturally fully formed and functioning arms absent of prosthetic devices and two (2) legs to the knee OR one (1) naturally fully formed and functioning arm absent of prosthetic devices and two (2) naturally fully formed and functioning legs absent of prosthetic devices. Prosthetics are not permitted. Casts are not permitted. Riders using a wheelchair must transfer from the wheelchair onto the ride. Due to the design of the seating safety device on this ride, exceptionally large or tall people may not be able to ride.

**Ride Access:** All Riders utilizing the AAP, excluding those using a wheelchair or ECV should enter through **THE FLASH** Pass entrance. Those using a wheelchair or ECV should enter at the exit ramp.

# Frosty Snow Hill (Holiday Sledding Hill)

A sled ride down a hill covered with snow.

Height Restriction: All guests under 42 inches must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. No lap children. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV should enter through **THE FLASH** Pass entrance. Guests will exit at a separate unloading area at the bottom of the hill. Due to the snow and terrain, Guests will need to walk to the pathway near the bottom of the hill when exiting.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

Open only during Holiday in the Park.

## **Gunslinger** (Swing Ride)

Circular swinging motion while elevated above the ground.

Height Restriction: Riders must be 42 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## **HARLEY QUINN Spinsanity**

High Thrill Anti-gravity experience spinning on three axes

**Height Restriction:** Riders must be at least 54 inches/137 cm tall but no taller than 77inches/196cm tall to ride this ride.

**Physical Requirements:** Each rider must maintain in an upright seated position with their back against the seatback during the duration of the ride and their arms, hands, legs, and feet inside the ride vehicle at all times.

**Extremity Requirement:** Riders must possess one (1) naturally fully formed and functioning arm absent of prosthetic devices and two (2) legs to the knee absent of prosthetic devices Prosthetics are not permitted. Casts may not restrict the rider from bending the elbow or knee, and may not restrict the restraints in any way. Riders using a wheelchair must transfer from the wheelchair onto the ride. Guest must be able to step up into ride unit.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

Loose Article Policy: Loose articles are not permitted on the ride and must be secured with a non-rider or secured in a locker. Loose articles of any kind (including but not limited to purses, backpacks, beverage containers, cell phones and keys) may not be taken past the queue entrance and cannot be left on the load/unload platform.

### **THE JOKER** (Free-Fly Coaster)

An exciting, high speed, free-fly coaster with drops and flips

**Height Restriction:** Riders must be at least 48"/122cm tall but no taller than 77"/196cm tall to ride this ride. May not exceed 300 lbs.

**Physical Requirements:** Each rider must be able to remain sitting up straight, keep their head against the headrest, their back and shoulders against the seat back, and their arms, hands, legs, and feet inside the ride vehicle at all times. No Prosthetics. No leg casts 
Arm casts may not restrict the rider from bending the elbow and may not restrict the restraints in any way. Riders must be able to sit properly, use all restraining devices, and stabilize self. Riders using a wheelchair must transfer from the wheelchair onto the ride. Guest must be able to step up into ride unit.

**Extremity Requirement:** Riders must have two (2) functioning legs that include the knee absent of prosthetic devices and at least one (1) fully functioning arm absent of prosthetic devices that includes at least two (2) fingers and a thumb.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

# Judge Roy Scream (Wooden Roller Coaster)

Mild coaster with medium drops.

**Height Restriction:** Riders must be 42 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride. No prosthetic devices.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## **JUSTICE LEAGUE: Battle for Metropolis 4D** (Interactive Dark Ride)

An interactive dark ride with turns and spins.

**Height Restriction:** All guests must be at least 42" to ride. Riders between 42"-48" must ride with an adult (anyone age 14 or older,) and must be seated in the middle or right seat of the row.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. Lap seating is not permitted. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride. Strobe lights are in use.

**Extremity Requirement:** Riders must have two (2) natural functioning arms with natural functioning hands capable of grasping and at least one (1) natural functioning leg with a natural foot.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

# La Fiesta de las Tazas (Tea Cups Ride)

A circular ride with spinning motion, fast turns and side-to-side forces.

Height Restriction: Riders under 42 inches must be accompanied by an adult and must sit toward the inside of the Fiesta Cup.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints must be fastened properly to allow guest to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. ## La Vibora (Bobsled Roller Coaster)

Olympic bobsled simulation with medium side to side motion and mild up & down hills.

Height Restriction: Riders must be 42 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least three (3) natural functioning full extremities (including natural functioning hand(s) and foot/feet) capable of grasping and stabilizing in order to ride.

**Ride Access:** Riders utilizing the AAP should use **THE FLASH** Pass entrance. Riders using a wheelchair or ECV should enter through the ride exit.

# **Looney Tunes Adventure Camp** (Children's Play Area)

A children's play area with climbing and slides.

**Height Restriction:** Guests under 42 inches tall must be accompanied by an adult. Adults over 54 inches tall may ride when accompanying a guest under 54 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. Slide one at a time in a forward seating position, feet first. Do not slide head first. Slides are for sliding down only, no climbing and no stopping. When exiting the slide, immediately leave the slide landing area. All play equipment should be used in a safe and correct manner. No climbing or standing on the outside of the play equipment, including the slides. No running or horseplay in the play area.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the entrance.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

# Marvin the Martian Space Rockets (Children's Circular Ride)

A gentle ride with some up and down motion.

Height Restriction: Riders must be over 36 inches tall and under 54 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## Mini Mine Train (Mine Train Roller Coaster)

A roller coaster for our smaller guests with mild drops and turns.

**Height Restriction:** All riders must be at least 36 inches tall to ride, riders between 36 and 42 inches must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seat belts and lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least three (3) natural functioning full extremities (including natural functioning hand(s) and foot/feet) capable of grasping and stabilizing in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

### MR. FREEZE Reverse Blast (Launched Roller Coaster)

Quick acceleration, high speeds, steep drops, fast turns, and inverted turns.

**Height Restriction:** All riders must be at least 54 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have two (2) natural functioning arms with two (2) natural functioning hands capable of grasping, and two (2) natural functioning legs with two (2) natural functioning feet in order to ride. No prosthetic devices.

**Ride Access:** Riders utilizing the AAP should use **THE FLASH** Pass entrance. Riders using a wheelchair or ECV should enter through the ride exit.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

Closed during Holiday in the Park.

## **New Texas Giant** (Hybrid Roller Coaster)

Exciting coaster with high speeds, steep drops, and fast turns.

Height Restriction: All riders must be at least 48 inches tall to ride.

Physical Requirements: Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. Due to the restraint devices on this ride, certain guests of size and physical dimension may not be able to ride. Guests with arm or leg casts that restrict the guest's appendage movement and/or impede the passenger restraints are not permitted to ride. All passenger restraints, including lap bars must be positioned and fastened properly to allow guest to ride. Lap bar must firmly contact top of the leg on thigh, with rider seated with their back against the backrest. No space is allowed between the lap bar and the top of leg. If the restraint does not press firmly against the top of the leg of the passenger may not ride, even if the passenger meets the minimum height requirement. Anyone attempting to create space under their lap bar will be ejected from the park. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride. No prosthetic devices.

**Ride Access:** Riders utilizing the AAP should use **THE FLASH** Pass entrance. Those using a wheelchair or ECV should enter through the ride exit.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

## Oil Derrick (Elevator to an Observation Deck)

An elevator ride to the viewing area at the top of the ride.

Height Restriction: None

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol.

Service animals may accompany riders on this ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

Closed during Holiday in the Park.

# Pandemonium (Spinning Roller Coaster)

Exciting roller coaster with moderate to heavy side to side motion, moderate to heavy spinning and mild up and down hills.

**Height Restriction:** All guests must be 42 inches tall to ride. Guests between 42 inches and 47 inches tall must be accompanied by an adult to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride.

**Ride Access:** All Riders utilizing the AAP should enter using **THE FLASH** Pass entrance, Riders using a wheelchair or ECV should enter using the elevator adjacent to **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## **THE RIDDLER Revenge** (Swinging/Oscillating Ride)

An exciting ride with circulating and oscillating up and down motion.

**Height Restriction:** All guests must be 52 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including shoulder harnesses and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast positioned that it does not impede restraints or fellow riders. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least two (2) natural functioning arms that extend at the minimum to the elbow and one (1) natural functioning hand capable of grasping on one of the two arms, and at least two (2) natural legs with lower extremities to the knee on both legs in order to ride. No prosthetic devices.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

## Roaring Rapids (White Water Rapids Ride)

Slight side to side motion, occasional side jolts and dipping, rafting simulation.

**Height Restriction:** Riders must be at least 36 inches tall to ride. An adult must accompany riders between 36 and 42 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride. You will get wet, possibly soaked on this ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass, via the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

Closed during Holiday in the Park.

## Rodeo (Spinning Ride)

A moderate ride with heavy side to side and front to back motion.

**Height Restriction:** All guests must be 48 inches tall to ride. Guests between 48 inches and 54 inches tall must be accompanied by an adult to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride. Rider positions may be adjusted to ensure proper weight distribution.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

# Runaway Mountain (Indoor Roller Coaster)

An exciting roller coaster with high speeds, steep drops, and fast turns all in the dark.

Height Restriction: All guests must be 48 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least three (3) natural functioning full extremities (including natural functioning hand(s) and foot/feet) capable of grasping and stabilizing in order to ride. No prosthetic devices.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the side door near the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## Runaway Mine Train (Mine Train Roller Coaster)

An exciting roller coaster with high speeds, steep drops, and fast turns.

**Height Restriction:** All riders must be at least 42 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least three (3) natural functioning full extremities (including natural functioning hand(s) and foot/feet) capable of grasping and stabilizing in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## **Shock Wave** (Looping Roller Coaster)

An exciting roller coaster with high speeds, steep drops, fast turns, and loops.

**Height Restriction:** All riders must be at least 42 inches tall to ride. To enjoy the VR experience, Riders must be 13 years of age or older.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride.

**Ride Access:** All Riders utilizing the AAP, must navigate the entrance ramp, starting at **THE FLASH** Pass entrance, in order to access the ride. Shock Wave was constructed before the American with Disabilities Act, so Riders must exit using the entrance ramp as well.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

## **Sidewinder** (Scrambler Ride)

A circular ride with spinning motion, fast turns and side-to-side forces.

**Height Restriction:** Riders must be 36 inches tall to ride. All riders between 36 and 48 inches must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts and lap bars, must be fastened properly to allow Guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride. Rider positions may be adjusted to ensure proper weight distribution.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## Silver Star Carousel (Carousel)

Low speed antique Carousel.

**Height Restriction:** Riders under 42 inches tall must be accompanied by an adult. If riding on a horse, the adult must stand next to them toward the inside of the ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride. Expectant mothers and lap children are only permitted when riding in a chariot.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping, one (1) natural functioning leg with a natural foot, and a second natural functioning leg to the knee to utilize a horse. Chariots require Upper Body Control and the ability to sit in an upright position and maintain an upright posture.

Service animals are permitted on this ride when accompanying a rider on a chariot.

**Ride Access:** All Riders utilizing the AAP may enter through the ride exit. Riders using a wheelchair or ECV should enter through the marked gate to the left of the exit near La Cantina stand. There is a wheelchair lift located to your right. Press the Bell button to alert the operator. The operator will assist prior to loading the next ride.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## Six Flags Railroad (Steam Train)

Slow moving, sit down visual tour of the park.

Height Restriction: None

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride) and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirements:** Riders must have upper body control and the ability to sit in an upright position and maintain an upright posture. If cannot maintain upper body control, must ride with a responsible adult.

Service animals may accompany riders on this ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

# Six Flags Speedway (Go Carts)

Indy racecar simulation. Heavy side to side forces, minor bumping.

This attraction requires an additional charge.

**Height Restriction:** Drivers must be 58 inches tall or over. Riders must be at least 40 inches or over and when carrying a passenger under 18 years of age, the driver of a double car must be at least 18 years of age or the parent or legal guardian of the passenger.

**Physical Requirements:** Drivers must exhibit sufficient visual acuity to operate the car safely. Drivers and passengers must maintain an upright seated position with their back against the seatback at all times during the ride durations. Arms, hands, legs, and feet must remain inside the go kart at all times. Drivers and passengers must have the ability to step up and down into the ride vehicle or have the ability to transfer from a wheelchair to the go kart.

**Extremity Requirements:** Drivers and passengers must have one (1) functioning arm, and two (2) functioning legs, or leg prosthetics which allow pedal control for both legs. Drivers must have the ability to hold and turn the steering wheel along with foot pedal control of the gas and brake pedal. Passengers must meet all the requirements to ensure safe vehicle and restraint operation. Casts may not restrict the rider from bending the elbow or knee, and may not restrict the restraints in any way.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

# Speedy Gonzalez' Truckin' Across America (Truck Convoy)

A child's ride that moves around a track with gentle turns.

**Height Restriction:** Children under 36 inches must be accompanied by a responsible person. Adults over 54 inches may only ride when accompanying a rider under 54 inches and only in the back seat of a truck.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow Guest to ride. Due to the restraints some large guests may not be able to ride. No lap children. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

## **SUPERMAN: Tower of Power** (Launched Tower Ride)

An exciting ride with sudden vertical acceleration and a sudden vertical drop.

Height Restriction: All riders must be at least 52 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including shoulder harnesses and seat belts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride. No prosthetic devices will be permitted on the ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

# Sylvester and Tweety's State Fair-is Wheel (Family Ferris Wheel)

Low speed Ferris Wheel ride. Minor swinging may occur.

**Height Restriction:** Riders under 42 inches tall must be accompanied by an adult. Adults over 54 inches tall must be accompanied by a rider under 54 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride. Lap children are permitted. No single riders

**Extremity Requirements:** Riders must be able to sit properly and stabilize themselves.

Service animals may accompany riders on this ride.

**Ride Access:** All Riders utilizing the AAP should enter through the ride exit. Riders using a wheelchair or ECV should enter through the exit and notify the attendant when they arrive at the wheelchair lift.

# **Taz Tornado Swings** (Family swing ride)

A gentle circular ride.

**Height Restriction:** Riders under 42 inches tall must be accompanied by an adult. Adults over 54 inches tall must be accompanied by a rider under 54 inches tall.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), and stabilize themselves throughout the entire ride cycle in order to ride. Lap children are not permitted. 275 pound maximum combined weight per swing.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

**Loose Articles:** Loose articles, including but not limited to purses, backpacks, beverage containers, cell phones and keys, must be secured in cargo/zipped pockets, zippered ride pockets (Runaway Mountain only) or article bins on select ride docks. All loose articles which cannot be secured must be locked in a locker, or left with a non-rider.

## **Texas SkyScreamer** (Spinning Swing Ride)

An exciting, high speed, swing ride with circular motion.

**Height Restriction:** All guests must be 48 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have two (2) natural functioning arms that extend at a minimum to the elbow and one (1) natural functioning hand capable of grasping on one of the two arms, and at least two (2) natural legs to the knee on both legs in order to ride. No prosthetic devices.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

## **Titan** (Steel Roller Coaster)

An exciting roller coaster with high speeds, steep drops, and fast turns.

**Height Restriction:** All guests must be 48 inches tall to ride.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. There may not be more than a 4¼ inch gap between the lap bar and the side of the car. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and two (2) natural functioning legs with two (2) natural feet in order to ride. No prosthetic devices. The only exception is if a rider has one (1) natural functioning arm with a natural hand capable of grasping, and one (1) prosthetic arm they may be allowed to ride if the prosthetic arm is firmly secured. If not firmly secured it must be removed to be able to ride.

**Ride Access:** All Riders utilizing the AAP should enter using **THE FLASH** Pass entrance, Riders using a wheelchair or ECV should enter using the elevator adjacent to **THE FLASH** Pass entrance.

**Loose Articles:** Loose articles of any kind, including but not limited to purses, backpacks, beverage containers, cell phones and keys, are not permitted on this rides. Loose articles on these rides should be left with non-riders, secured in lockers, zippered ride pockets (Texas Giant and Titan only) or left in article bins on select ride docks.

# Wile E. Coyote's Grand Canyon Blaster (Children's Roller Coaster)

A roller coaster for our smaller guests with mild drops and turns.

**Height Restriction:** All riders must be at least 36 inches tall to ride. Riders between 36 and 42 inches must be accompanied by an adult.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including lap bars, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. No leg casts. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride), use all restraining devices, and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least three (3) natural functioning full extremities (including natural functioning hand(s) and foot/feet) capable of grasping and stabilizing in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.

# Yosemite Sam's Texas Tea Cups (Child's Tea Cup Ride)

A child's ride that spins quickly.

**Height Restriction:** Riders must be between 36 inches and 54 inches.

**Physical Requirements:** Do not ride if you have any of the following conditions: recent surgery or illness, heart conditions, neck, back, or bone ailments, pregnancy, high blood pressure or aneurysms, or are under the influence of drugs or alcohol. All passenger restraints, including seatbelts, must be fastened properly to allow guest to ride. Due to the restraints some large guests may not be able to ride. Riders with arm casts must be seated with the cast toward the outside of the ride. All riders must be able to sit properly (facing forward, sitting upright, flat in the seat with their arms and legs inside the ride) and stabilize themselves throughout the entire ride cycle in order to ride.

**Extremity Requirement:** Riders must have at least one (1) natural functioning arm with a natural functioning hand capable of grasping and at least one (1) natural functioning leg with a natural foot in order to ride.

**Ride Access:** All Riders utilizing the AAP, including those using a wheelchair or ECV, should enter through the exit.
