

Dolphin Discovery Program Instructions and Waiver

Congratulations! You are enrolled in Six Flags Discovery Kingdom's Dolphin Discovery Program!

You must read all the enclosed information.

PLAN YOUR VISIT:

- Review your ticket for specifics, including the date and time of your encounter
- Allow ample time to park your vehicle and arrive at the meeting place
 - Plan to arrive at least 10 minutes prior to your start time, to get to your location on time
 - On days the park is open, it can take 30-60 minutes to park your car and get to the classroom
- **If you are more than 15 minutes late, you will not be allowed to participate in the day's program, and will have to reschedule for a \$50 fee**

REQUIREMENTS FOR PARTICIPATION:

Individuals not meeting these requirements will not be permitted to participate, and will not receive a refund.

- Minimum height is 48 inches, for safety purposes
- Children must be at least six years of age
- Children ages 6-11 must be accompanied by a paid adult participant or a chaperone
 - Chaperones join the classroom and locker room portion of the program
 - Chaperones do not participate in the in-water portion of the program
- Ability to swim is necessary to complete the program
 - Swimming ability is determined at the discretion of the Animal Care Specialist
 - Participants must be comfortable on their own in the water, while wearing a wetsuit
 - No life jackets will be provided, however, the wetsuits provide some buoyancy
- Any participant who is negatively affecting the animals or other participants, or who is not following the instruction of the Animal Care Specialists or Instructors will be asked to leave without refund

FOR A SAFE INTERACTION:

- **All jewelry/piercings and accessories must be removed or you will not be allowed to participate. NO EXCEPTIONS.** This includes, but is not limited to;
 - Rings
 - Earrings
 - Necklaces
 - Bracelets
 - Facial, tongue, dermal, or other piercings
 - Nail art jewels
 - Sunglasses
 - Hair Clips
 - Bobby Pins
 - Eye Lashes
 - Any hair ties other than plain elastic bands
- We recommend leaving all jewelry at home
- Lockers will be provided for any remaining items, and you may bring your own lock
 - Six Flags Discovery kingdom is not accountable for lost or stolen items

WHAT TO BRING:

- Six Flags Discovery Kingdom Dolphin Interaction Ticket
- Swimsuit
- Signed Consent Form
- Lock (if desired)
- Any Gift Certificates/ Vouchers (if applicable)

CANCELLATION/ RESCHEDULE POLICY:

- Rescheduling your program seven or more days from your original reservation incurs a \$25 fee
- Rescheduling your program six or less days from your original reservation incurs a \$50 fee
- There are no refunds

ANIMAL INTERACTION GUIDELINES:

- Six Flags Discovery Kingdom wants everyone to have a safe and fun interaction
- Animal Care Specialists' and Instructors' directions must be followed explicitly at all times
- If at any time you are uncomfortable with the directions given, please let your instructor know immediately
- While interacting with the animals, do not grasp or hold on to any area of the animal unless specifically instructed to do so by an Animal Care Specialist or Instructor
- Do not reach out or touch the animal without permission
- Keep hands away from the animals eyes, mouth, and blowhole
- When instructed, pat the animal gently with a flat, open hand—do not use fingernails
- For your safety, all participants are required to wear wetsuits and booties provided by Six Flags Discovery Kingdom
- The animals participation in this program is strictly voluntary
 - If the animals choose not to interact with the participants, the interaction will conclude
 - In the event of this, we will reschedule your interaction at no charge

Six Flags Discovery Kingdom reserves the right to alter or cancel any program due to animal well-being, weather conditions, or facility availability. We also reserve the right to remove any participant from the water if the staff feels his or her actions are endangering themselves, other participants, or the animals, or if he or she is disruptive to other participants. Please note that all program activities are subject to change.

Program start times vary depending on date and time of year. CHECK YOUR TICKET FOR YOUR INTERACTION DATE.

IF PARK IS OPEN ON THE DAY OF YOUR INTERACTION:

A) 10 a.m. Interaction Time:

- Park in main lot ahead of time
- DO NOT get on the tram
- Walk towards the main park entrance, until you see the Dolphin Discovery Headquarters
 - About mid-way between the parking lot and park entrance
 - Dolphin Discovery Headquarters is a bright blue building near the go-kart track
 - Do NOT go to the Main Gate if the park is not open, as you will not get to the classroom in time
 - Applicable parking fees apply

B) Noon, 2 p.m. or 4 p.m. Interaction Time —with park admission:

- Park in main lot ahead of time
- Enter at Main Park Entrance
- Meet inside the park
 - At the blue gates with a large dolphin silhouette between Ocean Discovery Pool (C) and Gifts From Under the Sea
 - Applicable parking fees apply

- Noon, 2 p.m. or 4 p.m. Interaction Time –without park admission:
- Park in main lot ahead of time
- DO NOT get on the tram
- Walk towards the main park entrance, until you see the Dolphin Discovery Headquarters
 - About mid-way between the parking lot and park entrance
 - Dolphin Discovery Headquarters is a bright blue building near the go-kart track
 - Do NOT go to the Main Gate if the park is not open, as you will not get to the classroom in time
 - Applicable parking fees apply
- We will pick up the in-park guests first, and will meet you at 5 minutes past the program start time. You may also enter this way if you wish to enter the park *after* the program.

IF PARK IS **NOT** OPEN ON THE DAY OF YOUR INTERACTION:

A) For any interaction start time:

- Park in lot in front of classroom
 - Dolphin Discovery Headquarters is a bright blue building near the go-kart track
- Enter the park at the Dolphin Discovery Headquarters

Waiver, Release and Indemnity Agreement and Publicity Release

For and in consideration of permitting _____ to enroll and participate in Discovery Kingdom's Dolphin Discovery Program and activities incidental thereto, including without limitation, activities involving close proximity to and contact with animals, as a participant on, from, or in the location of Six Flags Discovery Kingdom (the "Activities"), sponsored by Park Management Corp or Six Flags Theme Parks Inc., in the City of Vallejo, County of Solano, State of California, beginning on the ____ day of _____, 2018, the undersigned, for himself or herself and for his or her heirs, executors, administrators and assigns, voluntarily agrees that under no circumstances will the undersigned, or the heirs, executors, administrators or assigns of the undersigned prosecute or present any such claim or cause of action for personal injury, property damage or wrongful death against Six Flags Discovery Kingdom, Park Management Corp., Six Flags Theme Parks Inc, or any of their respective directors, officers, agents, servants or employees (collectively, the "Releasees"), whether such claim or cause of action arises from the negligence of the Releasees or otherwise.

It is the intention of the undersigned by this instrument to exempt and relieve the Releasees from any and all liability for personal injury, property damage or death in connection with the Activities. The undersigned hereby forever and irrevocably RELEASES, DISCHARGES, INDEMNIFIES AND HOLDS HARMLESS, each of the Releasees, from and against all losses, claims, damages, liabilities, costs or expenses (collectively, "Losses"), arising in whole or in part, directly or indirectly, from the Activities including, but not limited to, any Losses caused or alleged to be CAUSED IN WHOLE OR PART BY THE NEGLIGENCE of any Releasees. The undersigned further COVENANTS NOT TO SUE any of the Releasees with respect to any matter addressed by the Waiver, Release and Indemnity Agreement and Publicity Release.

The undersigned further authorizes Six Flags and Park Management Corp to take any steps necessary to insure the health of _____ in case of an emergency.

THE UNDERSIGNED HAS READ THIS RELEASE, UNDERSTANDS THAT HE/SHE HAS GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAS SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTENDS IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

The undersigned grants to the Releasees and their designees, the absolute right and permission to use the undersigned's name, voice, picture, and photograph for promotional purposes in any manner or media (including social media) whether now existing or hereafter created (including, without limitation, online), worldwide, in perpetuity, without notice to the undersigned and without limitation, condition, consideration, consent or compensation. The undersigned shall have no right of approval, no claim to any compensation, and no claim arising out of the use, alteration, distortion or illusionary effect or use in any composite form of any of the foregoing attributes of the undersigned's identity.
